

**OXFORDSHIRE COUNTY COUNCIL
(HENLEY-ON-THAMES REGATTA)
(VARIOUS ROADS, TEMPORARY TRAFFIC RESTRICTIONS) ORDER 2024**

WHEREAS Oxfordshire County Council (“the Council”) being the highway authority, in the interest of public safety is satisfied that traffic should be temporarily prohibited or restricted in various roads to minimise danger whilst the Henley Regatta (“the Event”) takes place.

NOW THEREFORE, the Council in exercise of its powers under Section 14(1), (5) and (7) of the Road Traffic Regulation Act 1984 and all other enabling powers hereby make the following Order:

1. Save as provided in article 3 to this order no person shall, when appropriate signage is in place, other than with the permission or under the direction of a police constable in uniform or civil enforcement officer, cause or permit any vehicle to proceed in any of the “Sections of Road” specified in Part 1 of the Schedule to this Order.
2. Save as provided in article 3 to this order, no person shall, other than with the permission of a police constable in uniform or civil enforcement officer, cause or permit any vehicle, to wait in any of the “Sections of Road” specified in Part 2 of the Schedule to this Order.
3. Nothing in Article 1 or 2 of this Order shall render it unlawful to cause or permit any vehicle to proceed or wait in any of the Sections of Road specified for any of the following purposes:
 - (1) Police, Fire or Ambulance services
 - (2) access to premises situated in or adjacent to that length of road
 - (3) emergency works to the road or to utility services in respect of water supply, drainage, the supply of electricity, gas or to communications.
4. Save as provided in article 5 to this order, no person shall other than with the permission of a police constable in uniform, cause or permit any vehicle to wait for the purposes of loading or unloading in the “Section of Road” specified in Part 3 of the Schedule to this Order.
5. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in any of the Sections of Road specified for the purpose of loading or unloading for any of the following purposes:
 - (1) Police, Fire or Ambulance services
 - (2) emergency works to the road or to services in respect of water supply, electricity or gas or communications.
6. No person shall, other than with the permission or under the direction of a police constable in uniform, cause or permit any vehicle to make a left turn as specified in Part 4 of the Schedule to this Order.

7. No person shall when appropriate signage is in place, other than under the direction of a police constable in uniform, cause or permit any vehicle to be driven in Hart Street other than eastwards between its junctions with Market Place and Thameside.

8. Nothing in articles 6 or 7 shall apply to police, ambulance or fire service vehicles being used for emergency services.

9. The prohibitions and directions imposed by the articles to this order shall apply in relation to any part of the specified lengths of roads to such extent and at such times as there are in place traffic signs (within the meaning of section 64 of the Road Traffic Regulation Act 1984) indicating that such prohibition or direction is in operation at that part.

10. The relevant provisions The Oxfordshire County Council (Various Roads – South Oxfordshire) (Map Based) (Prohibition and Restriction of Waiting and Permitted Parking) Order 2021 (as amended) shall temporarily be suspended, insofar as they permit waiting in the Sections of Road specified in this Order.

11. This Order shall be cited as The Oxfordshire County Council (Henley-on-Thames Regatta) (Various Roads, Temporary Traffic Restrictions) Order 2023 and will be in force from 2 July 2024 for the duration of measures associated with The Event.

SCHEDULE

Part 1

TEMPORARY PROHIBITION OF THROUGH TRAFFIC

Henley Bridge - that length of carriageway as is carried by Henley Bridge.

Thames Side - from its junction with Hart Street to its junction with Friday Street.

Part 2

TEMPORARY PROHIBITION OF WAITING

Thames Side - from its junction with Hart Street to its junction with Friday Street.

A4130 Fairmile - from a point approximately 125 metres northwest of its junction with Northfield End and Leicester Close, north-westwards for a distance of approximately 400 metres.

Deanfield Avenue - for its entire length, and that part of **Paradise Road** from its junction with Gravel Hill to its junction with Deanfield Avenue.

Greys Road - from its junction with Deanfield Avenue to its junction with Duke Street.

Pearce`s Orchard – for its whole length.

Part 3

TEMPORARY PROHIBITION OF LOADING & UNLOADING

Greys Road - from its junction with Deanfield Avenue to its junction with Duke Street.

Part 4

TEMPORARY PROHIBITION OF LEFT TURN

From:	Prohibited direction:	Into:
